 - a. Events include; Sheep Herding and Sheering demos
 - b. Classic North Andover Event that has a large following.
 - c. Craftsman and Crafters. Booth costs are as follows;
 - i. Crafter booths are \$50, Food Vendors are \$200
 - d. Cow Pie Bingo (to raise money for Santa Parade)
 - i. \$10/square for Cow Pie Bingo. \$1000 if the cow pie's on the square. Ten \$100 winners will also be drawn at random. All proceeds go to Santa Parade.

- 6. Sports Scholarship (Sylvie Foulds)
 - a. Fundraiser in March at Jamie's. There was a \$25 fee to participate and the money raised was for the scholarship fund. Stachey's Pizzeria provided Pizza. 75 people came. This event raised \$2300 between \$20 entrance fee and raffle Items. There have been no requests yet for scholarship assistance but we should see more coming up with more registrations coming up. 

Where To Start

- . Depends on the entity type.
- Sole Proprietorship and General Partnership require no State filing. Just start doing business!
- All other entity types require some type of State filing with the Secretary of State (and of course there is a filing feel).

... What To Do After Organization

· Compliance with formalities for entity type. + For example ...

- + Corporation must
- · File Annual Report.
 - + Hold Annual General Meeting
- Maintain Separate Bank Accounts (Persona/Business)
 Maintain Good Records (E.g., Minutes, Resolutions, Voting Records, etc.)
